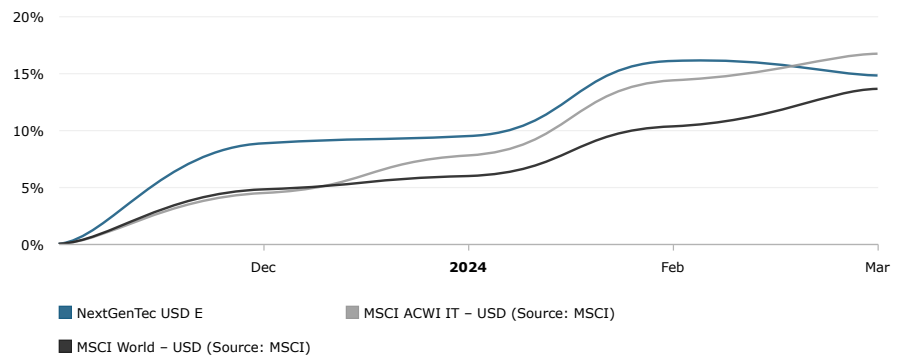
STRATEGY DESCRIPTION

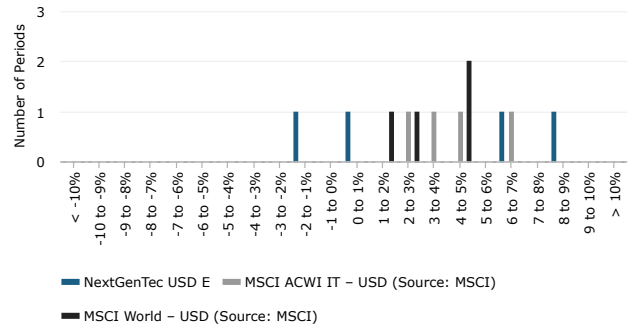

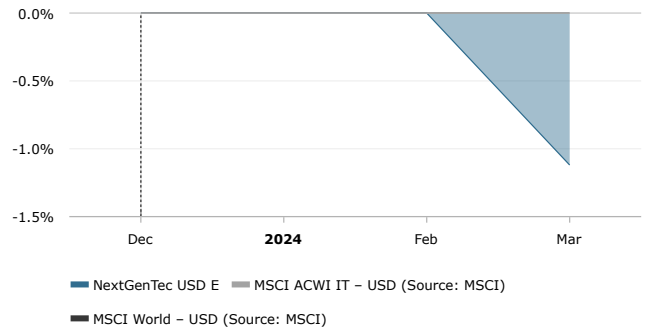
DISTRIBUTION OF MONTHLY RETURNS



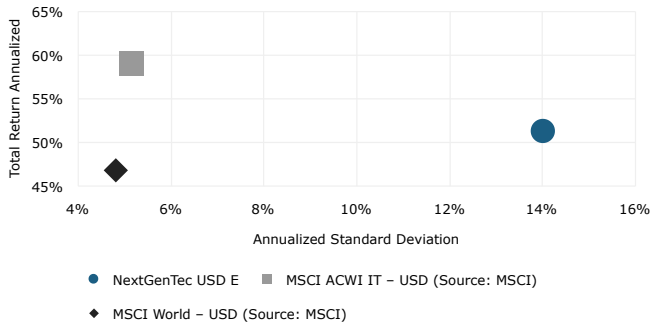

RISK/RETURN COMPARISON



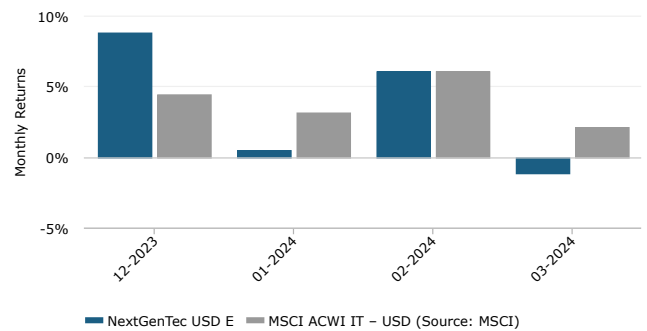
12 MONTH ROLLING ROR
