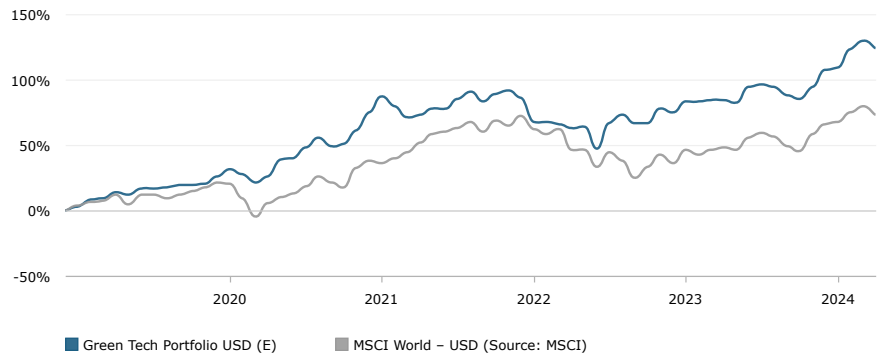

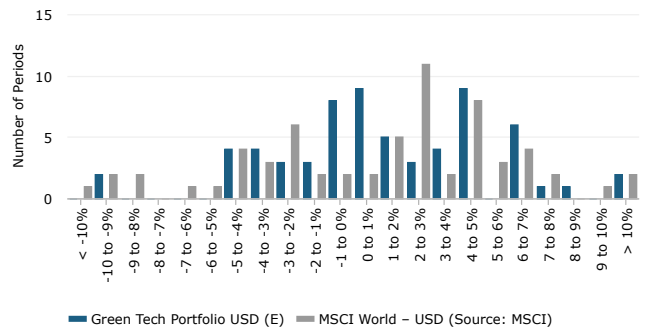

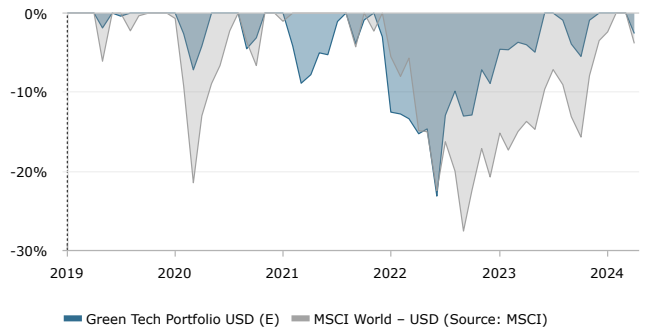
## DISTRIBUTION OF MONTHLY RETURNS



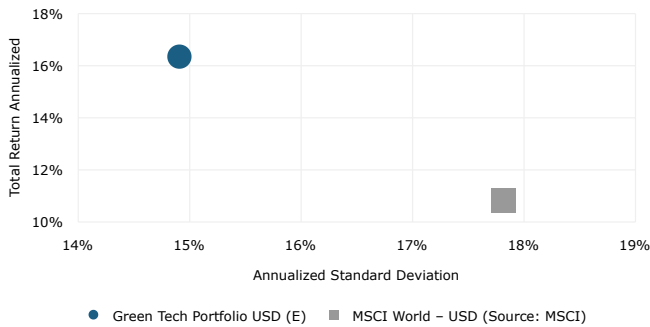

## RISK/RETURN COMPARISON



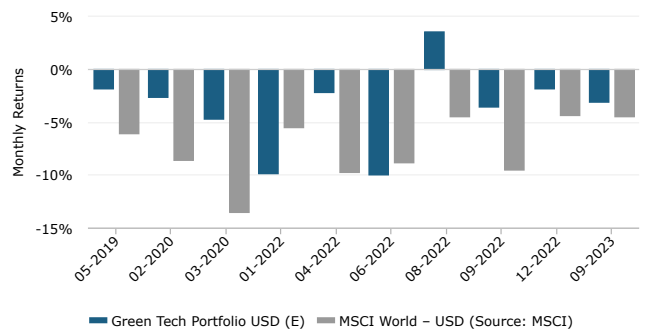
## 12 MONTH ROLLING ROR
