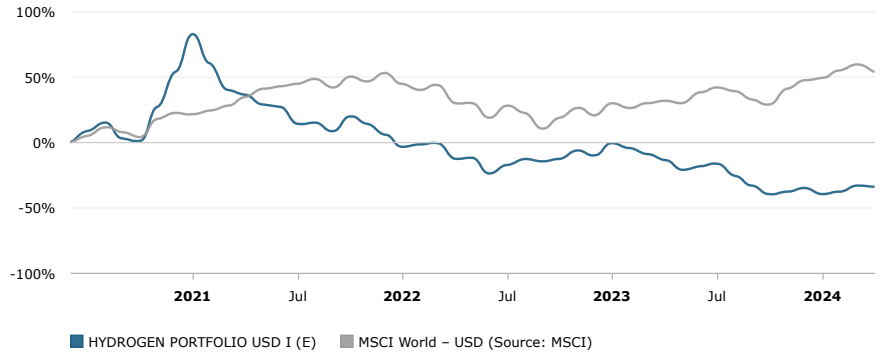

STRATEGY DESCRIPTION

The Hydrogen Portfolio invests in companies in the hydrogen sector. Stocks with the strongest momentum are selected from the following sectors: "Green Hydrogen Production," "Pure Plays," and "Solution Providers." The absolute and relative momentum are continuously analyzed. Stocks with the strongest momentum are chosen. If the momentum criteria we defined are no longer met, we consistently sell. The proceeds from the sales are reinvested if suitable new investments with momentum are available. If not, we may hold up to 49% in liquidity. This approach has historically helped reduce downside risk.

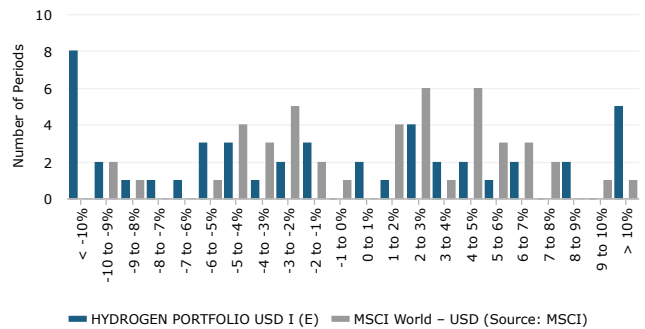

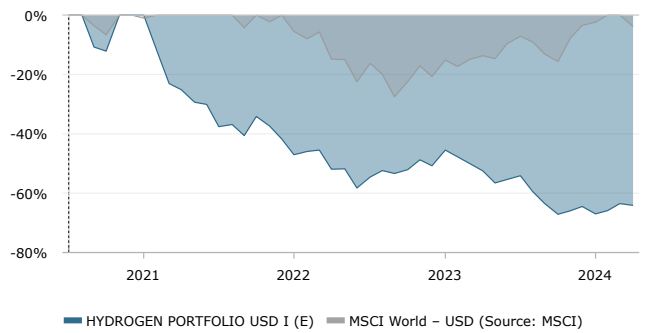
DISTRIBUTION OF MONTHLY RETURNS



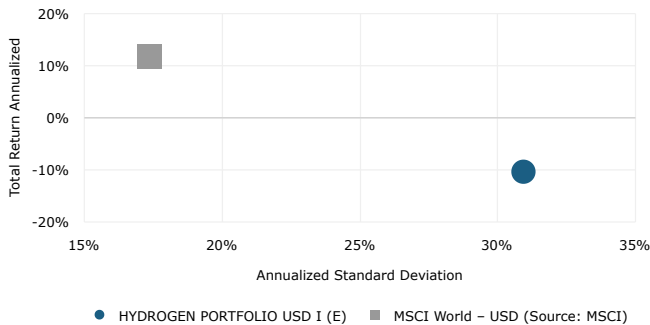

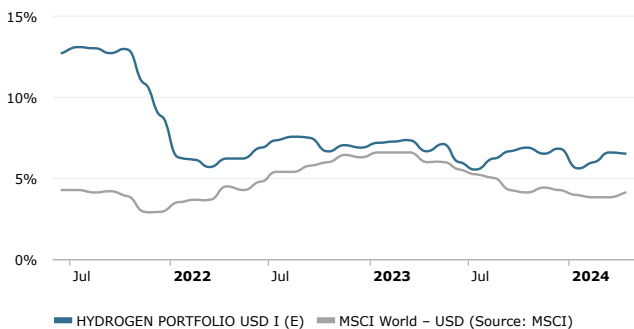
RISK/RETURN COMPARISON



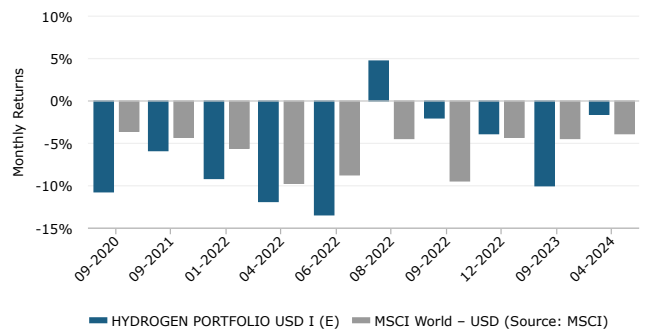
12 MONTH ROLLING ROR

Significant Risks for Investors
