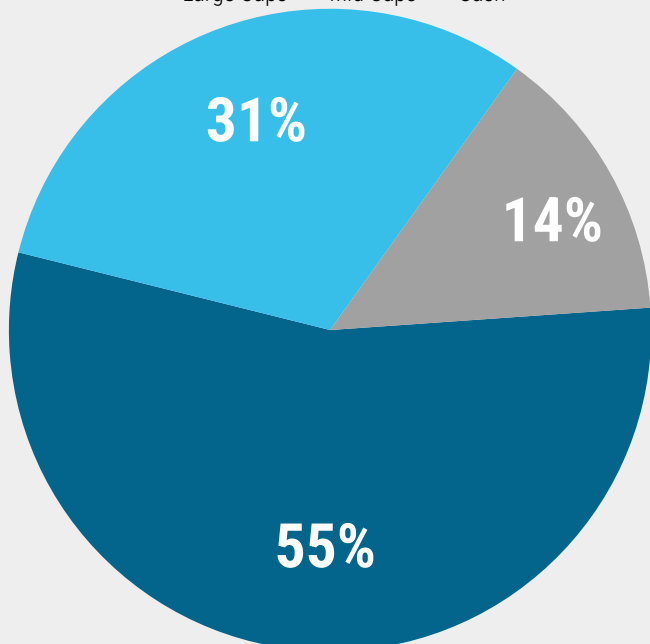

## MARKET CAPITALISATION

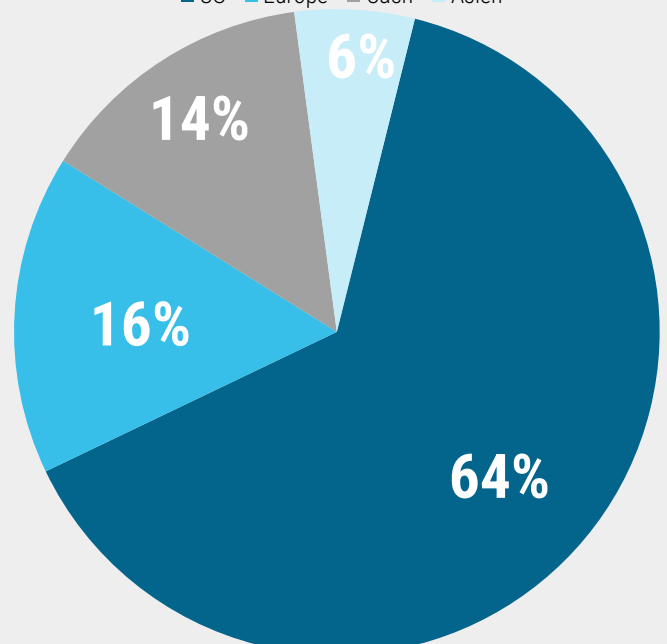
■ Large Caps ■ Mid Caps ■ Cash

### SIGNIFICANTE RISKS FOR INVESTORS
